| Abstract | Heritage Operations Subregion Boundaries (formerly Cultural Heritage Division Boundaries) consist of six broad areas - North West, North East, North Metro, South Metro, South West and South East. Heritage Operations is now part of Department of Premier and Cabinet (DPC) but there are still strong ties with Environment, Energy and Science (EES) in the Department of Planning, Industry and Environment (DPIE). Heritage Operations staff are located in EES offices and use the EES network. Administration includes sharing of NPWS management in the Aboriginal Heritage area. |

Lineage

Cultural Heritage Division Boundaries were created following the DEC restructure using both PWD and EPRD boundaries with a few extra changes for effective management. The name was changed from Cultural Heritage Division to Country, Culture and Heritage Division (CCHD) in 2010. For AHIMS administration the current PWG and EPRG boundaries are being used instead, for simplicity reasons. Depending on the user role, one or the other boundary restriction usually applies. The CCHD Region Boundaries as they are now, will be amended in the future to align better with roles and responsibilities. Followed existing PWD and EPRD boundaries which are a mixture of LGA boundaries, roads and rivers. The new Subregion boundaries follow LGAs but they are not coincident with Biodiversity Conservation Division boundaries which follow different LGA boundaries.
