<b>Abstract</b>	<p>The LDPM data provides an outline of the performance of the NSW planning system and information on local and regional development determined by councils and private certifiers.</p> <p>Councils provide the Department with information on each DA and Section 96 modification application (S96) determined by council, and on CDC's determined by council or private certifiers.</p> <p>The department issued councils with a template for data and explanatory material including data definitions. Councils generally extract their information from DA tracking databases or, for smaller country councils, DA registers.</p> <p>Data analysis was undertaken by the Department using standard calculations (for a detailed explanation, refer to the "Data Quality Statement" tab of the Summary Data attached as a resource to this data set ).</p>
