NSW NPWS, Sydney.</p> <p>The composition and extent of the present vegetation within Woggoon (6,565 ha) and Tollingo (3,232 ha) Nature Reserves in the Central West Region of NSW, is described and mapped from intensive quadrat samples, field traverses and aerial photograph interpretation. Woggoon and Tollingo Nature Reserves represent the largest eastern-most mallee remnants in NSW. Four vegetation communities are described and 152 species (158 taxa) of vascular plants recorded from 44 families, 21 of which are at their geographical limits or regionally restricted. These include four species listed as restricted plants in the Western Division of NSW. A small proportion of species (7%) are exotic. Both reserves are similar, but not identical in vegetation structure and composition, with several taxa unique to each reserve."</p> <p>VIS_ID 1007</p>

Lineage

Colour aerial photographs at 1:50 000 scale (taken in May 1996) formed the basis of the vegetation map polygons. The images were interpreted stereoscopically for patterns of vegetation and geomorphology, and then matched to the vegetation site data. A provisional vegetation map was drafted and the linework and the boundaries checked during ground-truthing. The study area was traversed and particular sites investigated to confirm polygon labels and resolve vegetation boundaries. The final vegetation polygons were then transferred and corrected to the topographic map sheets and coded, ready for digitising into a geographic information system.
